
CATA welcomes Honourable Shirley Ayorkor Botchwey as the 7th Secretary-General of the Commonwealth

For over 75 years, the Commonwealth has been a unique and powerful force for good. Now we must seize the moment to realise the transformation our societies seek."



CATA's First Webinar on E-Invoicing: Models of Implementation and Lessons Learned


