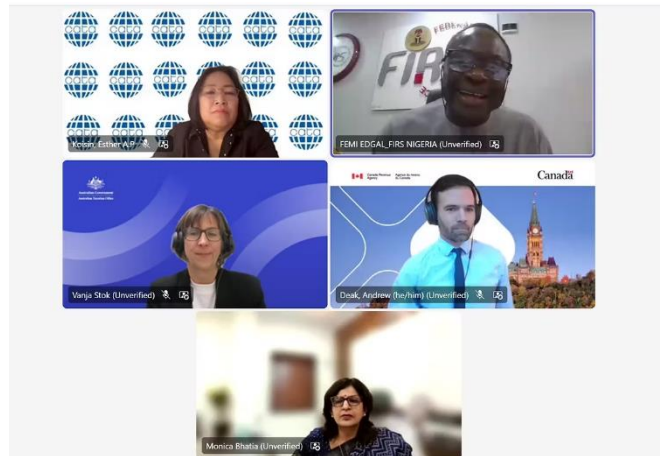


### The Appointment of Mr Rohit RAMNAWAZ as Director General of the Mauritius Revenue Authority and Chairman of CATA

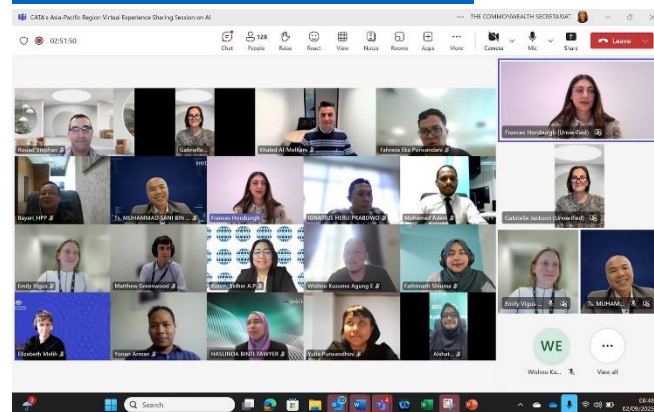
### [CATA and IBFD Hold Joint Training on Taxation of High-Net-Worth Individuals](#)

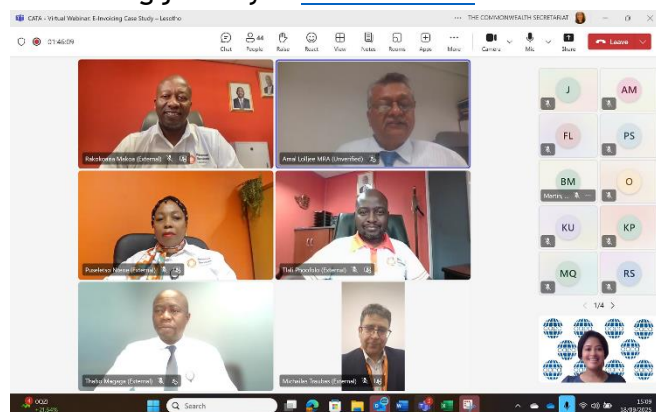

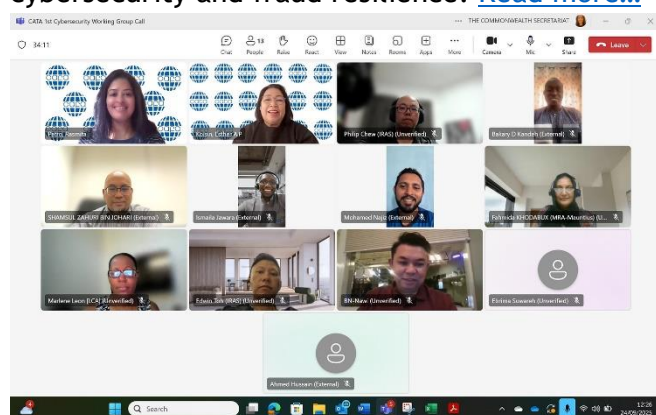
